## How the Donor Choice Program Works

- Eligible gifts will be forwarded in 2012 as specified by you.
- We will make every effort to contact you if any agency you choose is not eligible, or your information is incomplete or illegible.
- Ineligible agencies/designations include:
  - organizations that are primarily cultural, recreational, religious, political, occupation-based, animal welfare or schools
  - grant-making foundations and capital campaigns
  - designations to organizations to meet previous or personal obligations, such as tuition, pledges, dues or other membership costs
  - organizations outside of Wisconsin (except other United Ways)
